# **Bridge-to-Bridge 5K a Huge Success**

Despite threatening skies, a record number of approximately 140 runners and walkers turned out on what became a beautiful Sunday, Oct. 2, to take part in the Bridge-to-Bridge 5K Fun Run/Walk in Califon, sponsored by Friends of Califon Island Park (FOCIP) and Califon Area Merchants and Professionals Association (CAMPA).

Runners and walkers proceeded down River Road cheered on by local residents (some even serenaded runners with a vuvuzela!) to Hoffmann's Crossing, and then looped back down the scenic Columbia Trail, finishing at the historic Train Station in Califon. The overall winner with a time of 19:25 was Joe Wysocki, with Califon residents Matt Ramarge (21:07) and Mike Medea (21:13) not far behind in 6th and 7th place, respectively.

After the race, approximately 40 children ages 10 and under participated in the Little Cougars Fun Run at Califon Island Park, and all were winners with prizes of homemade chocolate chip cookies and ribbons. Prizes were generously donated by CAMPA members and proceeds from the race will go toward the fund to rebuild the playground at Califon Island Park. Many thanks to all the Califon-area residents and businesses who made this race possible, but special thanks go to the Califon Rescue Squad, Fire Company, residents of River Road, and countless volunteers who made this event possible. #### **Califon School News**

Califon School welcomes new staff members and transitions! Long-time special education teacher Leslie Weiss is now the 5th grade teacher, while Marie Heyduke teaches middle school math and special education. Patricia Cassa has joined the team as a part-time special education teacher. Kyle Kays and Susan Annunziata round out the new hires as fifth- and first-grade aides, respectively.

On Nov. 8, the Rutgers Science Explorer Bus will be back at Califon School for a second year. # **Town-wide Leaf Collection**

Leaf collection will be on the following Saturdays this year: Nov. 12, Nov. 19, Nov. 26, and Dec. 3. New Jersey mandates that leaves be bagged in biodegradable paper bags only—plastic bags are strictly prohibited. Residents can purchase the paper bags at Califon Lumber or at any major hardware store. Once bagged, leaves should be placed curbside for pickup on the dates listed above. The contracted vendor for pickup is Peter Rubinetti – Private Disposal, LLC. Alternatively, the borough encourages leaf composting if possible.
