OLD BUSINESS A. RESOLUTION – STORMWATER PROJECT – REJECTION OF REIVAX CORP. BID AND AWARD OF CONTRACT TO ROCK SOLID CORP.

The following Resolution was introduced for adoption:

WHEREAS, four (4) bids were opened and read in public on March 31, 2015 on a rebid for the project known as "RAILROAD AVENUE/MAIN STREET STORMWATER IMPROVEMENTS PROJECT"; CONTRACT NO. 15-01; and

WHEREAS, following the bid opening, the results were subject to **re-bid review** for determination as to the "lowest responsible bidder" and award of contract.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Califon that the receipt of bids for the **re-bid** for the subject project, opened on March 31, 2015, and the subsequent review of same, is subject to the following actions:

- 1. Following a detailed re-bid review, the Borough Attorney has opined that the bid of the apparent low bidder, Reivax Contracting Corp. in the amount of \$1,091,014.00, must be declared non-responsive and the bid **rejected**, due to the failure by Reivax to submit certain required documents at the time of bid opening.
- 2. Recommendation is hereby made that Contract 15-01 Railroad Avenue/Main Street Stormwater Improvements Project be **awarded** to Rock Solid Construction, Inc., the next lowest bidder, in the amount of \$1,168,831.00; subject to and pending the Authorization to Award by the EPA and the NJEIT.

COMMITTEE REPORTS

Councilman Medea reported that the Parks Committee met and discussed various matters. There was vandalism at the Park involving broken beer bottles in the mulch in the playground. Mayor Daniel led the cleanup and many thanks to him for his efforts.

The Park Committee members discussed the topic of installing cameras in the Park as a way to thwart the many incidents of vandalism. Councilman Medea discussed this issue with the Council and asked the Councilman Farmer resurrect his cost estimates from previous meetings where this subject was seriously discussed. Councilman Farmer agreed and said that he had spoken with Comcast who agreed that they would be willing to trench the parking lot to the shed so there would be equipment costs and probably administrative costs. Councilman Medea stated that providing the cost estimates to the Parks Committee members would enable them to take the project forward. Councilman Medea stated that the Parks Committee discussed better lighting at the park and updating signage. Councilman Medea reported that Washington Twp. has begun maintaining the ball fields and reported that there have been many applications submitted for usage of the fields this year. LTAA has only one team so that does open the fields for use by other organizations, however, the Parks Committee does want to draft updated usage rules and the fee schedule.

Kevin Baumann, contractor, has submitted a quotation to cut back brush and dead trees at the Park and to chip all for a cost of \$1900. The dumpster will be an additional cost. Council approved this project.

Councilman Medea reported that Railroad Ave. E. is in really bad condition. The DPW will need to fill the numerous potholes. There is a seam coming apart on Railroad Ave. W. caused by the freezing and thawing this winter that will need to be reported to our Borough engineer to request remediation by the contractor that did the recent Railroad Ave. W. project.

Councilwoman Riccio reported that the Recreation Committee will meet next Tuesday night.

Councilwoman Riccio read the Police report for the month of March and there was a surge in the calls in March; 140 residential and 63 traffic. Councilwoman Riccio reported that there is an obvious increase in police presence lately all over town.

Councilman Farmer reported that the Environmental Commission did not have a quorum so the last meeting was cancelled. Councilman Farmer was not able to attend the last Planning Board meeting but did report that the Planning Board has been engaging in an ongoing discussion about the R-1 and R-3 zones and related impervious coverage issues within these zones.

Councilman Farmer will research the ordinance recently adopted by Princeton, as reported by Councilman Medea.

Councilman Farmer announced to Mayor and Council that he is not seeking another term in the upcoming election.

Councilman Forrester reported that there is a vacancy on the Board of Education to be filled at the general election in November.

Councilman Forrester reported that the Board of Health was notified of a dog bite involving two Califon residents. The dog was quarantined.

The Board of Health is in contact with Andrew Gale from DEP regarding the status of the work on a new septic system at 74 Main St.

Councilman Forrester reported on the 4 cases of bad vaccine at various rabies clinics, causing 4 animals to get sick. The State was notified and the State asked municipalities to cancel their rabies clinics.

Councilman Forrester reported that feral cats account for 90% of rabies cases in the State.

Councilwoman DeBlasio reported that she; Alison Ramarge and Claudia Gangemi have been talking about the possibility of sponsoring a plein-air Art fund raising event at the Nellie Hoffman house sometime in September; possibly in conjunction with the 20th anniversary of the Columbia Trail. Plans may include an auction of the paintings; wine and cheese; tents, etc.

MAYOR'S REPORT

Mayor Daniel reported that when he heard from Chris Keiser, Parks Committee Chair, about the 18 or so broken beer bottles in the playground, he was aware that the Easter Egg hunt was scheduled for Sunday of that weekend. He, Bill Gensch and other volunteers helped pick out the pieces of broken glass from the mulch so it would be safe for the children to play on Sunday. There was also clear broken glass that needed to be cleaned up on the pavilion and on the basketball court.

Mayor Daniel reported that Chris Keiser has access to a free gazebo, which he intends to install in the park close to the cherry tree.

There were no comments from the public.

There being no further business to come before Council at this time, motion was made by T. Forrester seconded by P. Farmer and unanimously accepted to adjourn the meeting at 9:30 p.m.
