The Clerk will ask the Borough auditor, Anthony Ardito, to attend to finalize the budget figures with Council before Council introduces the budget at the regular meeting which will begin at 8:00 p.m.

NEW BUSINESS

There was no new business for tonight's meeting.

COMMITTEE REPORTS

Councilwoman Andersen reported that she found some old letters from Columbia Gas dated late 1988 referring to the installation of the gas pipeline through Califon Borough. She will follow up with representatives from Columbia Gas regarding the issue of the Califon Christmas tree.

The Board of Education will meet Monday, February 28th to approve the submission of the 2011-12 preliminary budget to the N.J. Dept. of Education. Councilwoman Andersen will attend this meeting. The Clerk will call the School Business Administrator to request a copy of the preliminary budget.

Councilman Baggstrom reported that the Planning Board will meet tomorrow. At their last meeting, the Planning Board reorganized:

Councilman Baggstrom reported that the Police Dept. issued a press release to the newspapers about the establishment of a canine unit within the Police Dept. Ptl. Cecere has trained a dog named Kobe to detect drugs and people. The dog sits and barks if he detects something; however, he is trained to attack if instructed to do so. Councilman Baggstrom reported that comments about the canine unit have been positive and favorable. Mayor Daniel reported that he had spoken to Washington Twp. Mayor, Ken Short, who suggested that the school allow the dog to visit the children.

Councilwoman Salisbury reported that she and Dep. Clerk, Karen Mastro, participated in a webinar for Sustainable Jersey on February 10th. There was a tutorial and discussion on how to navigate the Sustainable Jersey website. The Sustainable Jersey Green Team will meet on Tuesday, March 1 and they will invite Tara Sheppard from HART to attend.

Councilman Medea had no report; however, he asked if the Recycling Coordinator would be writing the article on recycling that she said she would work on. The Clerk responded that Ms. Brennan was ill and then away until March 1 and would not be able to write the article as planned. Councilman Medea said he could write it if he had until the end of the week. The Clerk said she thought that would be too late, however, she will check with the Crier Editor, Katie Vreeland, and see. If it is too late for a lengthy article, the Clerk said that perhaps she could insert a brief note introducing Helen Brennan as the new Recycling Coordinator and saying that she will be talking to the community about the new recycling requirements soon.

MAYOR'S REPORT

Mayor Daniel reported that he met with Ken Short, Mayor of Washington Twp. to discuss police matters. Mayor Daniel plans to contact the Mayor of Lebanon Twp., George Piazza, to arrange a meeting with him.

COMMENTS FROM THE PUBLIC

Bruce Morrow, Chairman of the Planning Board, reported that he and Planning Board member, Lavinia Trimmer, plan to attend a breakfast meeting tomorrow morning at 7:00 a.m. to discuss a new land use law.
